Law is an ever changing, topical subject. You will study the relationship between the law and morals, law and technology, law and justice, and law and society. Get into the good habit of each day scanning the headlines and list of

main stories on the BBC news website – <u>www.bbc.co.uk/news</u>. On most days there will be an item relating to the law which you can read in full, often relating to a particular topic that you will study. For example on 26<sup>th</sup> March 2020 it was reported that the crime of assault includes deliberately coughing on someone

during the coronavirus crisis. Also look out for law based films and documentaries. On Netflix we recommend 'When they see us' and 'The People v OJ Simpson' and on



OJ Simpson showing the gloves found at the murder scene of his wife and her friend do not fit him. This, in addition to many other issues led him to being acquitted, and the phrase "If the glove does not fit, you must acquit" becoming famous

youtube there is plenty of good material relating to cases you will study such as the Yorkshire Ripper, the Hillsborough Disaster and euthanasia campaigners Diane Pretty and Noel Conway.
